Campus Ministry Teams - IFI works to evangelize, serve, and disciple an increasing number of international students and scholars and their families out of love for Jesus Christ. Funds appropriated for Campus Ministry are used to serve internationals and ultimately make disciples of Jesus for the transformation of the world, in keeping with our mission statement to make Christ known among the nations. During the year the campus ministry staff, in collaboration with volunteers and churches, organized social, cultural, and spiritual activities that served approximately 3000 international students and scholars on 21 university campuses in the U.S.

Services to International Students and Scholars - IFI staff and volunteers conduct English Conversation Clubs and provide conversation partners to help international students and scholars and their spouses improve their English speaking and listening skills and help them navigate the complexities of American language and culture. IFI also provides internships for recently graduated international students during their OPT year, finds housing and/or employment for some of the student leaders involved in internships, and takes internationals to Christian conferences to encourage their spiritual growth and develop friendships. ----- PLEASE SEE SCHEDULE O FOR MORE descriptions of program service accomplishments.

Partnering with Churches and Volunteers - IFI works with churches to help them fulfill their discipleship and missions goals and to provide a means for them to practice Biblical hospitality. IFI has over 75 church partners and more than 2,500 active volunteers. Each year, IFI recruits additional churches, mobilizing tens and hundreds of new volunteers. IFI staff members work closely with volunteers from local churches to provide various services that address the social, cultural, and spiritual interests of international students and scholars. The objectives for engaging churches and volunteers are: 1) to train them in fulfilling God's command to "love the foreigners among us" in practical ways (short-term); and 2) to serve as a bridge between people interested in overseas ministry and their opportunity to reach the nations locally.

Note on Schedule L, Part IV, Line 1 ---- Donated Services and Business Transactions Involving Interested Persons ---- During a 2016 major renovation of IFI's apartment building that is used to rent to international students, IFI received contributed engineering and management services performed by professional contractors and engineers that satisfy the definition requiring recognition in Audited Financial Statements in accordance with FASB ASC 958-605. Consequently, a good faith estimate of market value of \$38,500 for such services was reflected in the 2016 Audited Financial Statements as donated services and is one of the reconciling items between the Form 990 and the Audited Financial Statements. During this major renovation of the apartment building IFI retained a general contracting firm that is owned by a member of IFI's Board of Directors. The agreement with the contractor was done on an arms-length basis and, in addition, the contractor donated a portion of the services discussed above. The project was completed in December 2016 and the total amount paid to the contractor, excluding the noncash donated services, was \$105,183 and was reported to the IRS on a Form 1099-MISC. At fiscal year end there was an account payable outstanding of \$28,683, that IFI paid within 30 days, related to the job. This is shown on Form 990 Part X, Line 22.
