# JOB DESCRIPTION

## **Summary/Objective**

The City Director is tasked with bringing forth a healthy IFI ministry location. The City Director's primary role is to recruit, coordinate, train and lead the City Impact Team in the fulfillment of the IFI vision. The City Director will speak on behalf of IFI in the churches of a certain geographical area and develop funding to support the joint local ministry.

- Has discernment and strong interpersonal skills
- Is faithful, loyal and dedicated to both the field staff and to IFI's mandate from the Lord to serve internationals and partner with them to make Christ known among the nations
- Exhibits a positive, professional manner
- Committed to evangelism and discipleship
- Ability to work under stress and be flexible
- Self-starter, able to work independently
- Ability to hold others accountable

## **Supervisory Responsibilities**

The City Director is responsible for the **oversight** of their IFI location by providing pastoral care and support, strategic and mission based focus, and administrative guidance and communication to members of the City Impact Team doing international student ministry at their location. These responsibilities include (but are not limited to):

- Build, manage and lead a City Impact Team consisting of a:
  - Community Liaison
  - Campus Ministry Lead
  - Campus Liaison
  - Online Content and Data Specialist
- Lead team meeting plan agenda, provide ongoing training, facilitate planning and encourage growth in staff relationship
- Meet individually with staff for assessment and encouragement
- Develop team expectations and assist staff who are not meeting expectations
- Make and execute a plan for strategic growth of the ministry location
- Develop an operating budget which includes:
  - The overall vision for the location for the coming year
  - Recommendations for any structural changes
  - Potential staff changes
- Make financial decisions related to the operating funds for specific programs within approved budgets
- Provide monthly reports addressing what has been happening in the ministry with regards to staff, students, churches and volunteers
- Maintain, update and ensure compliance with organizational policies and procedures

#### **Other Responsibilities**

- Develop strategic partnerships with Christian organizations, churches and community groups to assist the fulfilling the mission of IFI
- Maintain personal involvement in campus ministry, including:
  - Starting or participating in Bible studies for international students
  - Developing at least 2 ongoing relationships with international students
- Develop financial support for your personal ministry and for the needs of the location ministry as a whole



- Develop a personal support team through meetings and letters
- Conduct a local banquet in the area to present the needs and opportunities for ministry
- Develop a newsletter to send out to donors
- Other duties as assigned

#### **Work Environment**

The work environment of this position can be diverse, including a home office setting. Since communication with City Impact Team members is a must, access to phone, computer and/or tablet is essential.

#### Position Type and Expected Hours of Work

This is a full-time, deputized-fundraising, salaried position that requires both consistency and flexibility in scheduling. This position may be called on to work evenings and/or weekends in particular when participating in IFI events.

#### Travel

Depending on your location, travel to the National Office in Columbus may be required within the year. Plan on attending one or more conferences per year to connect with others in similar ministry and to gain further equipping for this role.

# **Required Education and Experience**

- Minimum of a Bachelor degree
- Minimum of three (3) years of work experience that encompasses management and leadership
- Experience in cross-cultural ministry

## **Preferred Education and Experience**

• Certificate-level completion of Perspectives on the World Christian movement is preferred and if not existent, should be completed within one year of employment with IFI.

## **AAP/EEO Statement**
